1. Senior Services Update, 2023-203

Rosie Walter, Senior Services Director

2. County Administrator Update 102423

Phillip Smith-Hanes, County Administrator

Phillip Smith-Hanes stated the building at 203 N 10th street has been finalized. It will first be used for storage due to the elevator situation. He also discussed the Juvenile Justice Authority study to convert the old jail into a Juvenile and Secure Care Center. The study was regarding the cost feasibility. The study was presented to the board and they are not going to move forward. He stated the County will move on and look at other reuse possibilities. Phillip Smith-Hanes also stated there is a vacancy on the County Planning Commission. Phillip Smith-Hanes stated the Commission will be at the new jail for a study session that will also be the ribbon cutting for the new facility; November 2nd will be the Chamber of Commerce Business After Hours, November 3rd is Slumber in the Slammer, and the 4th will be public jail tours. He stated there are three purposes for the Slumber in the Slammer event: 1. It is the most significant investment in public infrastructure in at least 50 years and an opportunity for people who invested in it to see it; 2. It will be a training opportunity for staff; 3. It is a fundraiser for jail programs. He stated the money left over from the t-shirt money will be reinvested back into programs provided to inmates.

3. Commissioner Comments

Commissioner Monte Shadwick asked about Schilling Road near the new housing facility and asked if both sides were owned by the City and the road is owned by the County. Phillip Smith-Hanes stated the City of Salina has never annexed either side of the road; they own the property up to the right-of-way.
