4. Budget Update

- Our health plan is running well with a loss ratio at 72.4%.
- Our dental plan is running a little high with a lost ratio at 112% which historically happens the first few months of our plan year, but levels off the rest of the year.
- HR budget is running at 34.46% which is in line with historical HR operations.
